ANNUAL REPORT FROM OUR PLANNING OFFICER

Comments have been submitted on planning applications in line with guidelines previously agreed by Forum members and comments given at the meetings.

My thanks go to Laura Creaven who publicises meetings and puts our newsletters on our website, and Kerry Leslie who volunteered to be my apprentice, like many things it didn't go quite as we planned but she intends to pick up the reins in the future when she can get some free time. Responses and discussions on Twitter are also invaluable (the Forum now has over 1700 followers).

Applications

There have been a number of applications to consider this year. These include;

- Outline proposals for former Tesco site (retail development to Pershore Road and dwellings to the rear of the site at Ripple Road)
- A continuing number of applications involving houses of multiple occupation
- 1256-1258 Pershore Road, demolition of existing building & construction of student residence (again)
- 1326-1344 Pershore Road
- 77-79 Cartland Road, construction of day nursery

The Forum has continued to bring enforcement matters to the attention of the Planning Dept.

In the coming year there will be further consideration of the applications for the former Tesco sites and the Stirchley Cooperative Development site at 1326 – 1344 Pershore Road.

Stirchley Neighbourhood Forum will continue to make comments on applications that affect residents of Stirchley Ward.

CHAIR'S REPORT

We have all been through so much since the last AGM - and Stirchley Neighbourhood Forum is no different. We have had to learn new ways of working. We've lost so many ordinary informal ways of keeping in touch. Familiar patterns have gone or been put on hold. But new starts have grown and keep coming. We're now at a point where, however long they take, new possibilities open up. As a Neighbourhood Forum, we learn so much from local experience and action and from each other, long-standing residents or recently arrived. Some plans will work. Some will not. Together we shall continue as a place where all can share. Thank you to all who have done and to all who will.

Since our last AGM, the pandemic has affected us all - and there are other changes. The long substantial history of the Co-op in Stirchley ended in January. New life came with Morrisons in July. The Arvin Meritor site is all but complete. New businesses are opening alongside some closures. The Forum with others has engaged with public planning for High Street development and we work closely with our Councillor, Mary Locke and with Karen Cheney and her City Council colleagues at the Baths. We still wait, patiently watchful, for developments on the SevenCapital site and the former bowling alley/gym. Alongside all these, we reflect and build on vigorous partnerships with our police, Library, health services, schools and many other local groups and businesses.

Despite everything, Stirchley is growing! The way ahead is not clear. We know however that we need each other. We believe that we must continue to be a means of common meeting and, as we can, of finding a common mind so that all can go on growing together.

My special thanks to my predecessor Peter Walker for his lively, faithful work as Chair for 14 years and also to my committee colleagues, especially Paula Aubrey our Treasurer and Sandra our Vice-Chair and indefatigable Planning Officer. Thank you also to the very many residents and colleagues who share in what we do and hope for.
